### Key points from Lowell Community Health Center

- Certain EHR barriers are limiting the implementation of diabetes screening
- Culturally tailored messaging, education support tools, and adapted curricula are needed to help support AA populations with prediabetes and diabetes.
- Need for more streamlined seamless workflow referrals for AA patients with prediabetes or diabetes
- Need to address underlying SDOH barriers contributing to diabetes risk or challenging management of diabetes.

### NCAPIP and Screen at 23

#### **Points of Emphasis**

- Over half of all Asian Americans with diabetes remain undiagnosed. The number of undiagnosed Asian Americans with prediabetes is even higher. Of these, a significant portion of Asian Americans at risk for diabetes or prediabetes appear to be at a "healthy weight", and aren't being tested.
- The American Diabetes Association, National Institutes of Health, and the Centers for Disease Control have all recently acknowledged that Asian Americans should be screened for diabetes at a lower body mass index, and 23 is that number.
- 23 isn't a redefinition of overweight or obesity, it's an indicator of potential risk, and it's a number to keep in mind to get checked by our doctors and live healthier.

- We need to push the Screen at 23 campaign (<u>www.screenat23.org</u>) among doctors, patients, and the public at large to help ensure that Asian Americans are Screened at 23. Together we can help uncover hundreds of thousands of patients with diabetes so they can start getting the treatment they need before complications arise, and help thousands more prevent diabetes outright.


